I am to state that the General Body of this council at its meeting held on 26-27/03/2015 considered the Council assessor report (17.05.2014) on the standard of examination and other teaching facilities available at Alluri Sitarama Raju Academy of Medical Sciences, Eluru for purpose of Recognition of MD(Paediatrics) qualification against increased intake from 04 to 08 and renewal of recognition of DCH qualification for 2 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the Council assessor's report (17.05.2014) and decided to recommend that MD(Paediatrics) qualification against increased intake from 04 to 08 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
