"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (11/12/2015) along with the Council Assessor's Report (May, 2015) and compliance dated 15/10/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(ENT) qualification against increased intake from 01 to 02 seats granted by Dr. NIR University of Health Sciences, Vijayawadu, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
