

- (iii) No student should be admitted in the above course till the final permission of the Central Govt. is granted.
- (iv) The applicant should send compliance to above mentioned conditioned including Bank Guarantee of required amount to this Ministry before 4.00 PM on 23rd May, 2014, wherever required, in favour of Medical Council of India, New Delhi valid for three years from a nationalized/scheduled Bank as per MCI's norms against starting/increase in seats in above said course(s) or the acceptance letter, if bank guarantee is not required failing which this conditional permission for starting of course/increase of seats shall stand cancelled which shall result in forfeiture of right of the college/institution to admit the students in the above course.

This permission for increase of seats in the above courses and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject. The college authorities may take up the matter for recognition of the qualifications under Section 11(2) of IMC Act at the time of first batch admitted against the course appears for final year examinations.




